**PART 1 GENERAL**

**1.01. COMPETITIVE COST SEALED BIDS**

Sealed Bids for the construction of the **EB Hamilton Sports Complex Improvements Phase 1B** will be received, by **Tift County Board of Commissioners**, in **Room 204** of the **Charles Kent Administration Building, 225 Tift Avenue North, Tifton, GA 31794**, until **11:30AM, Friday, May 24<sup>th</sup>, 2024**, local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

**1.02. CONTRACTOR LICENSE**

Any Contractor submitting a bid must show evidence of the Contractor's authority to conduct business in the State of Georgia. State Contractors license number must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. See Instructions to Bidders for additional bidding requirements.

**1.03. SCOPE OF WORK**

The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **EB Hamilton Sports Complex Improvements Phase 1B** as shown on the construction drawings. In general, construction consists of baseball/softball/tee ball fields, with associated fencing, ballfield lighting installation, irrigation, irrigation well pump, grading, erosion and sediment control, utilities, storm drainage, concrete sidewalks, and all associated measures for the complete project. Time allotted for completion of work is **180** consecutive calendar days to substantial completion. Work shall be complete and ready for contract closeout with **210** consecutive calendar days. All work shall be completed in accordance with the plans and specifications. The work will be awarded in **one (1) Contract**.

**1.04. PRE-BID CONFERENCE**

A pre-bid conference will be held at **11:00AM** local time on **Wednesday, May 8<sup>th</sup>, 2024**, at **Watkins & Associates, LLC, 1606 Whiddon Mill Road, Tifton, GA 31793**. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Upon request and receipt of the document payment indicated above, Watkins & Associates, LLC will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Engineer. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Office of the Engineer.

**1.07. PREQUALIFICATION OF BIDDERS**

Prequalification may be required of Bidders prior to the award of contract. At the Owner's request, detailed written evidence such as financial data, bonding capacity, previous experience, present commitments, and other such data may be necessary to assist Owner in determining Contractor's qualifications shall be provided per the Instructions to Bidders contained in the contract documents.

**1.08. BONDS**

All bid forms must be accompanied by a Bid Bond or a certified cashier's check in an amount not less than ten percent (10%) of the amount bid. All bonds shall be by a surety company licensed in Georgia with "A" minimum rating performance and financial strength of at least five (5) times the contract price as listed in the most current publication of "Best's Key Rating Guide Property Liability". The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing. Each Bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond.

**1.09. PERMITS**

All anticipated federal, state, or local permits required for the project have been applied for and are expected to be approved prior to issuance of the Notice to Proceed.

**1.10. GEORGIA SECURITY AND IMMIGRATION COMPLIANCE ACT AFFIDAVIT**

All qualifying Contractors and Subcontractors performing work with the **Tift County Board of Commissioners** must register and participate in the federal work authorization program commonly known as E-Verify, or any subsequent replacement program, to verify the work eligibility information of new employees. In order for a Bid to be considered, it is mandatory that the Bidder's Affidavit of Compliance with O.C.G.A. §13-10-91 be completed and submitted with the Bid.

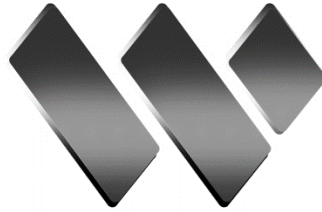
