**County Manager Comments:** The County Manager gave a copy of the newly printed Tift County Tax bills to each Commissioner. The design, color and print are different this year and the Tax Commissioner wanted the Board to look over the newly designed tax bill.

The County Manager will continue to do some research on presentation given by Conger LP Gas at the Workshop Session on the Auto Gas Fleet Vehicle Conversion to LP Gas usage. Commissioner Hughes was concerned about the extra weight on the vehicles. It was stated that it would only work on gas fueled trucks, not diesel. The County Manager stated that he needs to get a clearer picture about the conversion and what department we would benefit from the most. He will bring a recommendation back to the Board at the September meeting.
